ELIGIBILITY

The Summer School is open to law students (undergraduate, graduate, postgraduate and PhD students) and young professionals (attorneys, counsellors-at-law, patent attorneys, legal trainees etc.).

A good command of English is required to fully benefit from the programme. Candidates should have a computer / tablet / smartphone with internet connection.

The programme is designed for candidates who wish to obtain a deeper knowledge of IP law. We do not offer basic training in IP law during the course.

CERTIFICATE

A certificate of participation is awarded to participants who successfully complete the programme requirements (i.e. online participation in at least 80% of the programme activities).

European students can collect 2 ECTS for active online participation or 4 ECTS credits upon submitting an 8-10-page essay within 2 weeks of the end of the Summer School.
