## Programme for one day course in **INTERNATIONAL COMMERCIAL ARBITRATION**

### **COURSE CONTENTS**

The one day course will comprise a combination of talks, group sessions and workshops in which participants will be introduced to the philosophy behind the resolution of commercial disputes and how international arbitration sits within such a context. We will study the Arbitration Agreement (“Where it all starts”) and the Award (“Where it all ends”), as well as all the bits in between.

Participants will be invited to take part in a written assignment. Successful candidates will then be eligible to apply to the CI Arb for Associate Membership of the Institute. The details shall be available closer to the date.

The number of participants is very limited (max. 10 attendees per each training).
